The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
On **07/19/2023** at **18:20** (Specifically include facts constituting cause for arrest.)

On the above date and time, a vehicle crash occurred on Community College Parkway SE. The defendant's vehicle impacted a telephone pole, severing the telephone pole in two. The defendant had [REDACTED] in the vehicle. A witness came upon the crash, with the defendant in the driver's seat and [REDACTED] in the vehicle; and called 911. I and other officers responded to the scene. I obtained a statement from the witness that the defendant was behind the wheel of the vehicle which is registered to her.

I noticed the defendant was providing confused responses to Fire Rescue and witnesses described her as out of it. As I began speaking with her, I could smell a strong odor of an alcoholic beverage emanating from her breath. Her eyes were watery and very bloodshot. Her face was red. I could see her holding [REDACTED] who had visible injuries to her chin from the crash. During the investigation, I provided Miranda warnings and informed her of the DUI investigation. I could hear the defendant slurring her speech at times, continuing to provide unusual or confused responses; stating she was 13 YOA, then 15 YOA, then ultimately agreeing she was 24 YOA.

She was unsteady on her feet. I administered SFST. I saw two of the six clues, with the defendant being unable to follow instructions long enough to check for the other clues. I administered the walk and turn and the one leg stand. The defendant demonstrated clues of impairment during those tasks. I interviewed the defendant about her drinking. She reported she was drinking vodka. She reported she was drinking in the vehicle, with [REDACTED] in the vehicle. She reported she knew that it was dangerous to be drinking in the vehicle, while under the influence, with [REDACTED] in the vehicle, and that was an unsafe environment for the child (which resulted in injury to the child).

The damage to the telephone pole was approximately 20,000 dollars per FPL. The defendant [REDACTED] sustained injuries as a result of the crash.

I believed the defendant was under the influence, caused property damage and also personal injury, and had knowingly placed [REDACTED] in an environment/condition/place that she was likely to sustain injuries. I placed her under arrest. She provided four breath samples; returning at .266/.266 (an RFI occurred as I turned my radio back on) and then .265/.261 g/210L. While at the hospital, the defendant refused to sit in the hospital bed. I informed her several times she needed to and I was ordering her to sit/lay in the hospital bed. I informed her if she did not, I would charge her with resisting and place her in the bed. She told me to do it. So I charged her with resisting and forced her into the hospital bed. She was medically cleared and turned over to the Brevard County Jail.
